The Pioneer Children of Thomas Martin Jr. of York County, South Carolina

Thomas Martin Jr., of York County, South Carolina, raised eighteen children. Some of them remained near their natal home. Others were pioneers who spread across antebellum America, settling in Alabama, Arkansas, Georgia, Illinois, Mississippi, and Texas, with connections to Iowa, Missouri, Nebraska, Oklahoma, and Tennessee.

Thomas Martin Jr. was born 12 December 1778 in Chatham County, North Carolina. He died about 28 April 1855 in York County, South Carolina. His parents were Sabra Wilkie and Thomas Martin Sr., a Revolutionary War soldier. Thomas Martin Sr. moved his family from Chatham County to Lincoln County, North Carolina, in 1781. "Immediately after the close of the war," about 1783, he moved again, to York County, South Carolina. Thomas Jr. was a boy of about five years old when his family settled in York County.

Thomas Jr.'s first wife was Rhoda Washburn, daughter of Gabriel and Priscilla Washburn (née Jones) of Rutherford County, North Carolina. Sometimes called "Rodia," she was born about 1778 and died about 26 January 1808. They married about 1798 and by 1800 they probably had a daughter.

On 29 October 1798, Gabriel Washburn of Rutherford County deeded one hundred acres of land in York County, South Carolina, to Thomas Martin Sr. of York County, for five pounds. This was a small price considering land around this time usually sold for a dollar an acre. On 3 February 1809, Thomas Martin Sr. deeded the same one hundred acres to Thomas Martin Jr., again for five pounds. The land from Rodia's father was probably a dowry to the Martin family to help establish the young couple.

By 1808 when Rodia died, she and Thomas had four children.¹³ The couple probably named Priscilla, Sabra, Gabriel, and Thomas after their parents, Priscilla Washburn, Sabra Martin, Gabriel Washburn, and Thomas Martin Sr.¹⁴ Rodia's death was noted briefly in the records of the Buffalo Baptist Church, that she and her parents attended.¹⁵ Her father mentioned her death and her four children by Thomas when he wrote his will in 1822. Gabriel bequeathed five pounds each to Thomas and three married daughters, but he gave other children, including other married daughters, larger portions of his estate.¹⁶ Possibly those who received five pounds had received their inheritance before his death.¹⁷

About 1809, Thomas married Elizabeth (maiden name unknown). ¹⁸ She was born about 1788 and died 12 September 1868. ¹⁹ According to family stories, Thomas fathered twenty children, but only eighteen survived to adulthood. ²⁰ He mentioned all eighteen of his children who survived beyond infancy when he wrote his will in 1846. His fourteen children with his second wife were Bird, Berryman, Rhoda, Nancy, Posey, William, Anderson, Henderson, Elizabeth, Mary, Hicks, Absalom, Laquey, and Perry. ²¹ Elizabeth's firstborn child, Bird, was born about 1810. ²² Her last child, Perry, was born about 1832 when she was about forty-four

years old, ending a probable twenty-two-year span of childbearing years.²³ She and Thomas raised their children in York County, South Carolina, where they lived until his death in 1855.²⁴

After Thomas died, Elizabeth spent her remaining thirteen years on one third of Thomas's estate which included the "Mansion House" he provided for her "during her natural life." In 1855 their son Henderson Martin qualified as executor of the estate and sold the other two thirds of his father's estate. The land, 392 acres, was divided into four lots and sold. He also arranged an estate sale that was attended by family and neighbors on 23 October 1855. There was no mention of slaves in Thomas Martin Jr.'s 1846 will and none listed in the inventory and sales of his estate. Henderson was again the executor of his father's estate in 1868 after his mother died. Thomas's will emphasized that the estate he provided for Elizabeth was to be divided between his children.

On 6 December 1855, Elizabeth's youngest son, Perry, married Sarah Jane Beatty and he brought his bride to his mother's home. Elizabeth's sons, Posey, Henderson, and stepson, Thomas M. lived nearby. Many of Thomas's pioneer children had already left York County by 1855, and others followed suit later.

The Alabama Settlers in the 1830s

Priscilla, Sabra, and Gabriel

The strong demand for cotton and the need for fertile land fueled a land rush and period of expansion known as the Alabama Fever.³¹ Newspapers in South Carolina reported that "yield will exceed an average crop" in Alabama.³² Many families left South Carolina for Alabama.³³



Priscilla Martin's husband, Alexander Moreland, and Sabra Martin's husband, Freeman Logan,³⁴ purchased tracts of land from the United States government in Tuscaloosa, Alabama. The tract book for Townships 20 and 21 contains the details of their 1835 purchases, on the same page.³⁵ Their land was less than two miles apart in adjacent townships. Alexander Moreland bought eighty and one quarter acres, for \$100.31, and Freeman Logan bought just under forty acres, for \$49.64. Their land was located about six miles northwest of Northport, Alabama.³⁶



The Logan and Moreland families lived in Tuscaloosa in 1840. Alexander and Priscilla Moreland, ages in their forties, had nine children in the household. Freeman and Sabra Logan, ages in their thirties, had seven children. Neither family owned slaves.³⁷

By 1860, Freeman Logan's farm had grown from his original forty acres to more than six hundred acres. He owned two horses, two mules, six milk cows, three oxen, twenty-five cattle, twenty sheep, and twenty swine. In addition to raising livestock, he grew corn, ginned cotton, and harvested wool from his sheep.³⁸ Other produce for the year included Irish potatoes, sweet potatoes, three hundred pounds of butter, four tons of hay, beeswax, and two hundred fifty pounds of honey. Impressively, the family managed this enterprise without owning slaves.³⁹

Freeman died about 21 February 1874 at the age of about sixty-eight. In his will, he named his son, Bird Logan, as executor of his estate. After Freeman's death, Sabra lived with their daughter, Jane, and son-in-law, Isaac Martin, probably until her death in August 1884. After Sabra's death, Isaac Martin applied and was appointed administrator of the estate. The estate was under administration "de bonis non" with the will annexed, meaning he was appointed to finish what an executor had started, in accordance with the will. Jane purchased her father's land from the estate on 19 January 1885.

In addition to being their son-in-law, Isaac was also a nephew to Sabra. He was the son of her half-brother, Bird Martin. In 1902, he was among a group of veterans honored by the R. E. Rodes Chapter, United Daughters of the Confederacy.

Isaac Martin settled in Alabama after the Civil War, and was husband to two of the Logan daughters. The first was Cornelia, then Rebecca Jane, who also preceded him in death. He may have met Cornelia while acting with power of attorney for her parents, the appointment dated 31 July 1865. He was "of York County, South Carolina" at the time. 50

He was also the Reverend Isaac Martin, a member of and licensed to preach by Carroll's Creek Baptist Church. At the time of his death, at Sunday School, 12 July 1908, he was living with his daughter, Florence Turner.⁵¹

Thomas Martin Jr.'s third child, Gabriel Martin,⁵² also lived in Alabama from about 1837 until about 1856.⁵³ He was still in the Carolinas when he signed a petition to the state of South Carolina along with several relatives on 21 October 1834.⁵⁴ He lived in Randolph County,

Alabama in 1850 with his wife, Lucinda, and eight children ranging in age from two to twenty. The first four children born in North Carolina, and the last four born in Alabama. Twelve-year-old Thomas, born in Alabama, would have been born about 1838. Fourteen-year-old Jane, born in North Carolina, would have been born in 1836. The family moved to Alabama from Lincoln County, North Carolina, between their births. Gabriel was about thirty-five years of age by then. In 1850, Gabriel reported owning real estate worth two hundred dollars and he managed his family's farm. For Gabriel Martin did not own slaves, nor did several of his closest neighbors.

The Morelands Moved On to Mississippi

By 1850, Alexander and Priscilla Moreland had moved to Mississippi. They owned land and lived in Itawamba County. ⁵⁹ The couple had four children born in South Carolina, two born in Alabama, and six year old Joseph, born in Mississippi. It is likely that they moved from Alabama to Mississippi between 1840 and 1844 just before Joseph's birth. ⁶⁰

On 19 November 1856, Alex Moreland registered his stock mark as a "swallowfork under bit in each year [*sic*]." Not long after, Priscilla and Alexander gave Ralph Wright authority to claim Priscilla's inheritance from her father's estate. Mr. Wright, by power of attorney, signed a receipt on their behalf on 12 January 1858, for one hundred dollars and fifty-six cents. Priscilla had already received one hundred dollars from her father sometime before 1846 when he wrote his will.

In April 1870, Alabama formed Prentiss County from Itawamba County.⁶⁴ The Moreland family lived in Booneville.⁶⁵ By 1880, Alexander was an eighty-year-old widower living with his son, Thomas Moreland in Prentiss County, Mississippi.⁶⁶ Priscilla probably died sometime after the census taker visited in August 1870 and before the 1880 census.⁶⁷

The Georgia Migration of the 1840s

Rhoda, Nancy, Anderson, Hicks, and Gabriel

During the early 1800s, politicians, lawmakers, and citizens campaigned for taking over Indian lands in the southern states. After negotiations and betrayals, state and federal authorities forced the Cherokee to leave the southeastern states, including those who lived in northwest Georgia. This journey of a thousand miles began in 1838-39. South Carolina newspapers reported that the military was engaged in moving Indian populations across the Mississippi. This removal is now known as the Trail of Tears, because of the deplorable conditions and great loss of life during the journey. An 1846 treaty included provisions for giving up the Cherokee rights to land east of the Mississippi River.

Cherokee Indian Territory in Georgia, which became Cherokee County in 1831, was the parent county of Cass (later renamed Bartow), Cobb, Floyd, Forsyth, Gilmer, Lumpkin, Murray, Paulding, Union, and Pickens.⁷³

On 6 July 1885, The Atlanta Constitution newspaper published a story titled "The Collinses." The reporter interviewed William J. Collins, who was at the time the superintendent of the Bartow County "pauper farm." He told the story of how, forty-one years prior, his father James Collins had led a wagon train with fifty-one people to Gilmer County, Georgia, from Cleveland County, North Carolina. Several children of Thomas Martin Jr. migrated with them.

Rhoda Martin and Ransom Collins started married life in Lincoln County, North Carolina. ⁷⁶ By the time the family settled in Gilmer County, Georgia, about 1844, the couple had six children. ⁷⁷ In the summer of 1859, Ransom and Rhoda made a trip back to York County to receive part of Rhoda's inheritance from her father's estate. ⁷⁸ Ransom also collected inheritance monies for two of his nieces, Elvy Moss and Dulcena Martin. ⁷⁹ Elvy was the daughter of Wiley

Collins and Nancy Martin, and Dulcena was the daughter of Susan Collins and Berryman Martin. 80 They both inherited from Thomas Martin Jr. through their deceased Martin parents. 81

By 1860, Ransom and Rhoda lived on a farm of a hundred and sixty acres where they raised livestock consisting of thirty sheep, forty swine, a few milch (milk) cows, as well as wheat, and Indian corn. Three of their children lived on their own, and seven still lived at home. By

During the Civil War, Ransom, age 54, enlisted in July 1863 with the Cherokee Legion of the 107th Regiment of the Georgia Militia, organized for home defense.⁸⁴ While their son, Miller, was away fighting with the 23rd Infantry Regiment,⁸⁵ Ransom was involved in a conflict at home with "Raskels that fools with him." Miller desperately wanted to help his father, saying he would give everything he had for a furlough.⁸⁶ This may have been connected to a feud that ended in the deaths of Ransom's sons, Berry and Fielding, and the injury of Julia Ann at her wedding in 1865.⁸⁷ Around 1867, possibly because of that tragedy and the lawless state of the area during Reconstruction,⁸⁸ Rhoda, Ransom, and others set out intending to go to Texas. Their son, Miller, and his family stayed behind in Georgia.⁸⁹

Nancy Martin and Wiley Collins moved to Gilmer County, Georgia about 1844. 90 By 1850, the couple had seven children. The youngest, Roxanna, born in June, had a twin that didn't survive. 91

Nancy Martin Collins was born about 1814. 92 No record explicitly mentions her death, but she likely died in February 1851. 93 Wiley probably died shortly after, in March, since a receipt in his name shows he paid for "dry hides" on 1 March 1851. 94 Wiley's estate paid for two sets of funeral materials. The first was February 1851, the second set was dated 22 March 1851. 95 Twenty-four-year old Dr. Robert W. Foster attended to Nancy or Wiley, or both, and charged the estate for medicine, visits, mileage, and attention. 96 A nurse, Emeranday D. Moreland, charged for one week of work. 97 In addition to caring for the sick, she probably helped care for baby Roxanna and the other young children. Before the Civil War, families handled burial preparations themselves. 98 Local carpenter, Stephen Bradley, built the Collins's coffins. 99 Someone in the family, or the carpenter, probably lined the coffins with the cambric and white flannel, and dressed the outside with the black calico, then trimmed it with braid held in place with tacks and screws. 100

Davis Collins paid fees to the probate court for granting his administration of the estate of Wiley H. Collins on 5 July 1851. On voucher number three, he paid for two coffins at \$2.50 each. Since all seven of their children listed on the 1850 census were still living in 1860, the two coffins would have been for Wiley and Nancy. By 1860, the youngest Collins children lived with Nancy's and Wiley's siblings. Mary Elizabeth and Susan Roxanna lived with Nancy's

brother, Anderson Martin. ¹⁰³ Anna J. and Martha lived with Nancy's sister, Rhoda, and Ransom Collins. ¹⁰⁴ Martin, still single, worked as a carpenter in Whitfield County, ¹⁰⁵ and Emaline lived with her married sister, Elvy Moss, in Pickens County. ¹⁰⁶

Another Martin Collins lived in Pickens County in 1860, also a carpenter, but he was married to Derinda and was six years older. The Martin Collins who was Thomas Martin Jr.'s grandson by his daughter Nancy lived in Whitfield County, and married Sarah Batson there on 26 December 1866. 109

Anderson Martin married Susan Martin on 23 January 1848 in Gilmer County, Georgia. Two years later, they lived in Cherokee County, along with two children, Dulcena, age thirteen, and Lincy, age twelve. These were Susan's children by a previous marriage. These were Susan's children by a previous marriage.

Susan Martin, who married Anderson, was the widow of Berryman Martin, Anderson's elder brother, based on the following:

- She was the apparent mother of Dulcena Martin in a census record. 113
- She was the mother-in-law of Dulcena's husband Spencer Yancey. 114
- Anderson referred to Dulcena as his niece in a letter to his brother. 115
- Dulcena Martin was the only remaining heir of Berryman Martin, and she received her father's share of Thomas Martin Jr.'s estate. 116

Susan was probably Susannah Collins, born August 1814.¹¹⁷ Susannah's daughter, Dulcena, assigned power of attorney to Ransom Collins in 1859 so he could collect her

inheritance from her grandfather's estate.¹¹⁸ In a January 1872 letter to his brother, after Elizabeth Martin's death, Anderson referred to Dulcena as his niece. The letter included a second power of attorney assigned to her uncle, Henderson Martin. She was Dulcena Yancey by this time.¹¹⁹

In 1870, Anderson and Susannah lived in Pickens County next to Dulcena and her husband, Spencer Yancey. ¹²⁰ Their niece, Susan, lived with them, age twenty, and she worked as their housekeeper. ¹²¹ Their modest farm produced wheat, corn, oats, wool, sweet potatoes, butter, and molasses. ¹²² By 1872 the couple had moved to Cartersville, Bartow County. ¹²³ The Yancey's also moved at about the same time. ¹²⁴ Anderson treated Dulcena as if she were his own child. In the will he wrote in 1881, he left all remaining property to her, after providing for his widow. ¹²⁵

Anderson died 20 April 1884 and was buried in the Oak Hill Cemetery, Cartersville, Georgia. The Oak Hill Cemetery was originally associated with the Ebenezer Methodist Church. Almost twenty years later, Susannah was buried beside him after her death, 4 July 1903. She outlived her two husbands and all three of her children.

Hicks Martin was born in York County, South Carolina, 10 March 1822. By the time he was twenty-two, he was in Forsyth County, Georgia, where he married Margaret Casey. He was probably part of the Collins extended family group that included his siblings, Rhoda, Nancy, William, and Anderson.

By 1850, he and Margaret had four children, William H., Rhoda E., Frances M. and James A., all born in Georgia. He and Margaret were both born in South Carolina. Hicks farmed

land he owned, worth about one hundred dollars.¹³⁰ Their small farm of forty acres supported two milk cows, two cattle, fifteen swine, and produced ten bushels of wheat, a hundred and fifty bushels of corn, ten bushels of oats, three bushels of peas, ten of Irish potatoes, thirty bushels of sweet potatoes, and fifty pounds of butter during the year.¹³¹

Hicks Martin became a physician in the 1850s and was enumerated as such beginning with the 1860 census. The 1864 Militia Enrollment list for Carroll County, District 1152, described Hicks as 42 years 10 months of age, with an occupation of physician. In 1881, Georgia law required physicians to have a license from the licensing board and that it be recorded with the Clerk of Courts in the county of residence. The Register [of] Medical Practitioners lists Hicks Martin of Mt. Zion, Ga., born York District, South Carolina with a diploma from Reform Medical College of Macon, Georgia, registered 29 November 1881.

In a book by Jenny Martin Fagg, a descendant of Hicks Martin, ¹³⁵ she published a copy of an agreement dated 12 August 1902 between three children of Hicks and Margaret for their care in their old age. ¹³⁶ The agreement stated that J. A. Entrekin, husband of Margaret Cordelia, ¹³⁷ would take his wife's parents into his home and provide for them for the rest of their lives. J. A. Martin and F. A. Martin agreed to pay twenty dollars from their future shares of the estate. In 1910, Hicks was living with daughter, Rhoda Entrekin and her husband, Eli. ¹³⁸ The agreement apparently didn't last since Hicks's obituary stated that he was living with his youngest son, Dr. F. A. Martin at the time of his death, 4 June 1914. ¹³⁹

Hicks Martin's wife Margaret died 24 February 1903. Hicks died in Carroll County, Georgia, leaving real estate valued at about four thousand dollars. He and Margaret were buried at Mount Zion United Methodist Cemetery. His obituary described his interests. Dr. H. Martin joined the Zion Masonic Lodge No. 508 in the 1860's. He helped found the Methodist Episcopal Church at Mt. Zion, organized the Sunday School in 1858, and served as a minister. Has been died at Mount Indiana.

Gabriel Martin stated on his pension application of 1 January 1894, that he had lived near Jasper, Pickens County, Georgia, for fifty years, which would be since about 1844. However, he and his family lived in Alabama in 1850. He probably lost track of what year he moved from Alabama to Georgia, and on other questions he couldn't answer he explained that he was old and helpless and that his mind was feeble due to being old, at ninety-two years of age. 146

Gabriel applied for a pension against his service in the Georgia Militia from July 1863 to January 1864 when he was discharged at Rome, Georgia. He would have been sixty years old at his enlistment, possibly an early recruit as one of "Joe Brown's Pets." Governor Brown lost his state army to Confederate conscription and built his replacement militia by recruiting men older and younger than draft ages, which was between 17 and 50 by 1864. The county enumerated Gabriel on "a list of Infantry from Pickens Co. under the Govenors [sic] Proclamation for Volunteers for Home defence [sic] for Six months." On the same list of sixty-three recruits, the county listed his son, B.H. Martin, and brother-in-law, Ransom Collins.

Gabriel may have left Alabama when he learned of his father's death. He was probably in York County, South Carolina, when he sold his interest in his father's estate to his brother, Bird

Martin, on 8 October 1856.¹⁵⁴ Afterwards, he was probably in the neighborhood of Pickens County, Georgia, before 1858 since his daughter Caroline J. Martin was married there.¹⁵⁵ She was enumerated with her new family, Francis Pettigrew and baby William. Her brother, Berryman Martin, age twelve, was also in her home in Jerusalem township.¹⁵⁶

As he later explained in his pension application, he lived with his son Berryman Martin. The census taker enumerated them as two families in the same house on the 1880 census. Gabriel, age seventy-six, Lucinda, age sixty-nine, and Berryman, age thirty-five lived in Truckwheel, Pickens County. At age ninety-two, Gabriel applied for a pension for his Militia service. He stated that his children supported him and that his wife had died five or six years earlier. 158

The Arkansas Settlers Before and After the War

Laquey and Rhoda

The newspapers in York County, South Carolina, and probably other places, published stories about the opportunities and way of life in Arkansas. ¹⁵⁹ In a diary of the time, Mary Davis Brown named many people in her social circles who left York County for Arkansas because of land for sale there. ¹⁶⁰

Laquey Martin and William Neal may have married about 1850.¹⁶¹ She was enumerated as "Laky M. Neal, 19" in a household by herself, between William Neal's family and several Rippy families on the 1850 census in Cleveland County, North Carolina.¹⁶² A possible explanation could be that on the 6th of September the census taker visited the neighborhood and asked for "The Name of every Person whose usual place of abode on the first day of June, 1850, was in this family."¹⁶³ If William wasn't yet married on the first of June, his parents would have included him in their list of family members, and the enumerator may not have wanted to count him twice by listing him with Laquey, too.

On 23 October 1855, William Neal was among the buyers at the estate sale of Thomas Martin's property. He bought five pounds of tobacco, two lard kettles, a small trunk, and a spinning wheel. Around this time, local newspapers reported on the conditions in Arkansas, describing "the most beautiful and productive farms in the Southwest" with clear water and an abundance of minerals. Locals who had moved to Arkansas wrote back and described the benefits of modern travel on river boats and railroads, as well as the "truly grand" scenery and fertile land. York County resident, Mary Davis Brown, wrote in her diary of "the great stir in this country about going to arkances" and her many neighbors who were going there. 167

On 7 September 1857, William Neal received Laquey's inheritance from her father's estate from Henderson Martin, executor, in York County, South Carolina. Laquey's nephew, Isaac Martin, signed as a witness. About three years after, Laquey and William and their three children moved to Sugarloaf Township in Sebastian County, Arkansas. Their fourth child, William, was born there about May or early June of 1860.

When Ransom and Rhoda Collins left Georgia in 1867, they intended to move to Texas. In a letter to their son Miller, they told him that people coming back from there told of hard times "and their looks proved it." They decided to change course from Little Rock, Arkansas, and headed north. By December 1867, they had settled in Benton County, in the northwest corner of the state, partly because it was friendly to "rebels." Their newlywed daughter, Sallie and son-in-law, William Dodgen moved with them. Their eldest son Miller, a deputy sheriff, stayed in Georgia.

Rhoda and Ransom were buried in the Hico Cemetery of Siloam Springs, Arkansas. Ransom died 21 October, 1890 and Rhoda died 21 January 1897. 174

Oklahoma Indian Territory

Laquey

Oklahoma became a state on November 16, 1907.¹⁷⁵ Laquey Martin Neal was buried in Muldrow, Sequoyah County, Oklahoma, her date of death inscribed as 10 July 1886.¹⁷⁶ Her son, Jacob Henderson Neal, ¹⁷⁷ had lived in the Sequoyah District of the Oklahoma Indian Territory, as an "intruder," since 1876.¹⁷⁸ On his 1906 marriage license in Sebastian County, Arkansas, he and his intended reported that they lived in Muldrow, Cherokee Nation Indian Territory.¹⁷⁹ Laquey's eldest son, Alvin Hicks Neal, ¹⁸⁰ was married in Pottawatomie County, Territory of Oklahoma, in 1901 and listed his parents as "W^m Neal" and "L. Martin," and his place of birth as South Carolina.¹⁸¹ Also of note, Laquey apparently honored her brothers, Henderson and Hicks, when she named these two sons.

Illinois, Wisconsin, Nebraska

Absalom

Absalom Martin was born about 1828 in York District, South Carolina. ¹⁸² In October 1855, at the estate sale after his father's death, he purchased a sorrel colt, fodder, two lots of oats, and various farm tools. ¹⁸³ On 17 December 1857, he signed a receipt for his inheritance of \$148.54. He also witnessed the receipt for Alexander and Priscilla Moreland by their representative, Ralph Wright, on 12 January 1858, along with his brother, Perry. ¹⁸⁴

Fifteen years later, when he was about age forty-five, he was a farm laborer living in the McHenry County, Illinois, household of Geo H Stewart. He was apparently unmarried. On 16 September 1871, he went to a notary office in Richmond township, McHenry County, Illinois, to write a power of attorney assignment to his brother, Henderson Martin, who was the executor

of their parents' estate.¹⁸⁷ A few years later, on 9 May 1875, he wrote a letter to Henderson thanking him for sending fifty dollars by express.¹⁸⁸ The money was part of his inheritance after their mother died. He said the winter had been very hard and the spring quite cold, with snow on the first of May.¹⁸⁹ Notably, he did not mention family or a sweetheart, only his horse.

"... I did not think I would write but a few lines when I commenced as you did but I have made quite an episle of it though I must close it soon hoping to hear from you often I am busy with my horse now for a while let this do for the presant love to all dont forget to write yours as ever

A. Martin ",190

The following year Absalom married Mercy Bent on 4 June 1876 in her home town of Kenosha, Wisconsin. ¹⁹¹ On the marriage application he gave his parents' names as Thomas and Elizabeth Martin, and Mercy's parents' names, Enoch and Johanna Bent. ¹⁹² Absalom was forty-seven and Mercy was twenty-two when they married. ¹⁹³ The couple probably lived in Absalom's neighborhood in McHenry County for about two years. By 1880, the family lived in Greeley County, Nebraska, on their own farm. They gave their children's information as Dora, age three, Eva, age two, and Clemmie, age eight months. Dora and Eva were born in Illinois, but Clemmie was born in Nebraska. ¹⁹⁴

They only stayed a few years then moved to Clarke County, Iowa. A daughter, May, was born there about 1883, but she apparently did not survive to adulthood. 195

On 6 October 1893, the state of Wisconsin granted a divorce to Mercy from Absalom and she reverted back to her maiden name. The divorce decree named only three children, Clemmie, age fourteen, and two adult daughters, Dora and Eva. 196

Absalom moved back to Richmond, Illinois, and continued making a living with horses until he died on 20 June 1904 at 2 p.m. The doctor reported his death and the county clerk

recorded his death details with place of birth, South Carolina, age seventy-four, marital status as divorced, occupation as horseman, and place of death as Richmond Village. 197

His small estate consisted of a book of accounts, a stallion, road wagon, harness and a garden. The appraisers valued his horse services account at three hundred ten dollars. The undertaker, P. K. Wright, was paid one hundred dollars for the funeral, casket, and flowers. The Reverend Mr. Lumsden, of the M. E. [Methodist Episcopal] Church, was paid five dollars.

After the administrator collected and paid debts, and sold the horse, he divided the proceeds between three heirs: Mrs. Dora Korah of Grand Crossing, Illinois, Mrs. Eva Hampton of Chicago, Illinois, and Miss Clemmie Martin of Independence, Missouri. They each received sixty-eight dollars. ²⁰⁰

The Texas Settlers

Elizabeth and William

In his will written in 1846, Thomas Martin Jr. listed Elizabeth Goforth as one of his daughters. Probate of his will began in 1855 and spanned more than fifteen years. Although she was mentioned with her husband as "George W Goforth and Elizabeth his wife" in the probate records and newspaper notices, no documents gave her location. Power of attorney documents, letters, and receipts for their inheritance distributions linked her siblings back to their family, even as they moved over the years.

George Goforth and Elizabeth lived in Union County, South Carolina in 1850.²⁰³ Union County is just south of York County.²⁰⁴ George worked as a miller and the census taker recorded his birth state as North Carolina. His age was thirty-three and Elizabeth was twenty-six, born in South Carolina. The enumerator listed them with five children, presumably their own. The first two children were born in North Carolina, the other three in South Carolina; Reuben, Emily, Sarah, John, and Caroline.²⁰⁵

On 2 September 1857 in York County, South Carolina, G. W. Goforth signed a receipt to Henderson Martin, executor, for his wife's inheritance.²⁰⁶ On the same day, he sold a property called Taylor's Mill Shoal on Buffalo creek to his brother-in-law, Thomas M. Martin.²⁰⁷ Two

other brothers-in-law witnessed the transaction, Posey Martin and Henderson Martin. Between September 1857 and the 1860 census enumeration, the George W. Goforth family moved from South Carolina to Rusk County, Texas.

In 1860, G. W. Goforth, forty-two, a farmer born North Carolina, lived in Rusk County, Texas. He lived with Elizabeth, thirty-seven, born in South Carolina, Reuben and Emily, born North Carolina, Sarah E., John A., C. A., Mary L., Newton C., and G. W., all born South Carolina. The youngest, G.W. Goforth, a child of three, was born about 1857, probably just before the family set off for Texas.²⁰⁸

By 1870, the Goforth's Texas farm consisted of 327 acres of land with seven cows for milk, ten cattle, and twenty swine. They also grew corn producing about 400 bushels that year.²⁰⁹

The 1870 census for Rusk, Texas, lists Geo W Goforth, age fifty-five, born North Carolina. His wife, Elizabeth, is not listed. Caroline Alice, age twenty, born South Carolina, is the second member of the household. Mary L, Newton C, and Geo W, were all born in South Carolina, and all about ten years older than the same names on the 1860 census. Thomas H., age 8 and Charles J., age 4, were born in Texas.

Elizabeth was not listed on the 1870 mortality schedule for Rusk County, so she probably died between 1866, when Charles was born, and 1869, prior to the census year. Descendants gave her death date as 12 November 1868. George Goforth was not enumerated on the 1880 census, but sons Reuben and Charles lived in Gregg County. They probably did not move. A northern section of Rusk County was added to Gregg in 1874.

A descendant of Elizabeth and George, John Truman Smith, was an honoree of the Family Land Heritage Program of the Texas Department of Agriculture in 1975. The program recognized pioneer families with farms and ranches having continuous production in the same family for one hundred years. In the profile of "Goforth Angus Farm – 1872", George Washington Goforth Sr., of Kings Mountain, North Carolina, was described as the founder. His wife was given as Elizabeth Martin Goforth who died 1870, and George Sr. was said to have died about 1872. Its

William

Before he lived in Texas, William Martin probably migrated to Georgia with his siblings and Collins in-laws in 1844. He worked as a farmer in Gilmer County, Georgia, in 1850, age thirty-two, born in South Carolina. His wife, Elizabeth, age twenty-five, was born in North Carolina. Their three youngest children were born in Georgia, but the eldest, eight-year-old Nancy, was born in North Carolina. Their first child born in Georgia was five-year-old Henderson, likely named after his uncle. William and Elizabeth probably married before Nancy's 1842 birth, and the family migrated about 1844, as did William's siblings who settled in the same area of Georgia. 219

William's household was enumerated twice on the 1850 census, by the same census taker, Coke A. Ellington. The first interview was made 5 October 1850 and the second was almost two months later, on 29 November, both in Gilmer County. The ages reported were slightly different, probably due to a different respondent. The individuals were the same except that the second enumeration included Anna Collins, age seventy-five, who was born in South Carolina. It is likely that she was Elizabeth's mother and the family was there to take care of her. Sometime after 1853, the family moved to Marshall County, Alabama, but just for a few years.

On 14 February 1857, William signed a receipt to Henderson Martin for one hundred forty-seven dollars and thirty-four cents, his share of his father's estate. His brother, Absalom,

witnessed the receipt.²²⁴ The next record for him in his father's probate file was on 27 February 1871, when William assigned power of attorney authority to his brother, Perry Martin, of York County, South Carolina, for the purpose of collecting his inheritance from his mother's dower. This time he lived in Lincoln County, Tennessee, near the Alabama state line.²²⁵

Next, the family moved to Jack County, Texas, between 1871 and 5 November 1879 when William bought land there. William and Elizabeth apparently still worked their farm when he was in his sixties. Their farm had fifteen acres of tilled land and ninety-two acres of woodland. Their livestock consisted of four cows for milking, a few cattle to sell, twenty swine, and twenty chickens, from which they also made butter and gathered eggs. On 31 December 1880, William and Elizabeth sold part of their land to their son, Joseph, for one hundred dollars. Both Elizabeth and William appeared before the county clerk that day. The transaction is reflected in the 1882 tax roll where W. M. Martin had fifty-seven acres of the original Ahrenbeck tract and J. L. Martin had fifty acres of the one hundred seven that William purchased in 1879.

In 1906, a published profile of George P. Whitaker mentioned his marriage to a daughter of William Martin, the widow Mrs. Martha Jones, in 1894. The profile also stated that the Martin family came to Jack County from Lincoln County, Tennessee.²³¹

William and Elizabeth died between 1881 and 10 October 1883. Their children described them as deceased in a deed between heirs. The deed transferred the fifty-seven acres to eldest son, Henderson Martin. The grantors were J. M. Martin (James M.), J. L. Martin (Joseph), Martha Martin Jones, and the heirs of Nancy Martin Graves. William's name appeared on tax rolls for several years after his death, probably because the deed was not recorded until 1899 after all parties had appeared in front of a notary to acknowledge the deed.

Correlation of Census Data for William Martin's Family

A table comparing census data across four decades captures their migration. The first three censuses are linked with James M Martin's data along with his parents. Joseph adds to the connection between 1860 and 1870, and Martha links them from 1870 to 1880.

Only one child's death certificate correctly named William and Elizabeth. Joseph L. Martin's informant, his wife, gave his parents' birth place as Georgia, probably because Joseph was born there.²⁴⁰

Conclusion

Most of the children of Thomas and Elizabeth remained connected to the Methodist denomination, some as founders and leaders in their respective churches. Thomas's first wife and parents attended the Buffalo Baptist Church, therefore the strong Methodist influence probably came from Elizabeth. She and Thomas raised their children to be independent and adventurous adults.

Also of interest, neither Thomas Martin Jr., nor his children, owned slaves during the antebellum period even though all of them were of legal age between 1825 and 1855. Neighbors and associates, and the Washburn family, for example, owned slaves. Apart from Dr. Hicks Martin, physician, and Absalom Martin, the horseman, the rest of the family made their living at farming.

One Line of Descent from Thomas Martin Jr.

Generation One

1. Thomas² Martin (Thomas¹), born 12 December 1778 in Chatham County, North Carolina.²⁴¹ He died about 28 April 1855 in York County, South Carolina.²⁴² Thomas married first Rhoda Washburn,²⁴³ about 1799.²⁴⁴ Rhoda was born about 1778 and died about 26 January 1808.²⁴⁵ Thomas next married Elizabeth (maiden name unknown), probably about 1809.²⁴⁶ Elizabeth was born about 1788 and died 12 September 1868.²⁴⁷

Thomas and Elizabeth lived on about 470 acres of farmland that straddled the North and South Carolina state line in what is now Cherokee County, South Carolina and Cleveland County, North Carolina.²⁴⁸ The parcel of land that holds the Martin Family Burial Ground was probably part of their land, and it lies on both sides of the state line.²⁴⁹ The township address for its current owner is Blacksburg, South Carolina.²⁵⁰ The back half of the parcel is in Cleveland County and adjoins a property with a township address of Grover, North Carolina.²⁵¹

In 1850, their farm consisted of 80 acres of improved land and 390 acres unimproved. Their livestock consisted of three horses, three cows for milk, four oxen, seventeen cattle, twenty-two sheep, and two hundred sixty-six swine. They produced four hundred fifty bushels of corn, twenty bushels of oats, ten pounds of wool, twenty pounds of sweet potatoes, one hundred fifty pounds of butter, thirty pounds of beeswax. Their orchard produce was worth thirty dollars.²⁵²

In addition to the food produced on their land, the family likely harvested fish from the nearby waterways. Buffalo Creek, mentioned in their deeds, is a branch off the Broad River. ²⁵³ Sometime before 1855, Thomas and his sons, Perry, Henderson, Thomas M., Posey, and grandson, Washington Martin, and their neighbors signed a petition to the state of South Carolina. The petition requested the appointment of commissioners of fish sluices for a section of the Upper Broad River beginning from an area called Ninety-nine Islands to the North Carolina state line. ²⁵⁴ Commissioners of fish sluices had the responsibility to see that no one blocked the waterways so that fish could freely move up the river. ²⁵⁵

In a diary entry of 16 May 1857, Mary Davis Brown mentioned "a great fishing party" that her family attended. The Martin family likely did the same. Mary Brown's family lived about seventeen miles southeast of the state line, in the Beersheba community of York County. 256

The children of Thomas and Rhoda (Washburn) Martin were:

- i. PRISCILLA MARTIN, born before 4 August 1800,²⁵⁷ died between 1870 and 1880, probably in Prentiss, Mississippi.²⁵⁸ She married Alexander Moreland, probably before 1828.²⁵⁹ They moved several times and their children were born in South Carolina, Alabama, and Mississippi.²⁶⁰ Her life is described in *The Alabama Settlers in the 1830s* and *The Morelands Moved On to Mississippi* sections above.

- Mary was almost thirty years old at the time of her first marriage. 314 Her sisters all married at much younger ages.
- Green Martin did not inherit after Mary's death, although he bought from Thomas Martin's estate in 1868. The law did not allow illegitimate children to inherit. 316

19. Perry³ Martin (Thomas², Thomas¹), born about 5 August 1832, died 18 January 1920 in York County, South Carolina.³²⁸ On 6 December 1855 he married Sarah Jane Beatty of Cleveland County, North Carolina.³²⁹ Of their five children, all daughters, only two survived to adulthood.³³⁰

Perry Martin, the youngest son of Thomas and Elizabeth, spent his life farming in York County. During the Civil War, he served as a Sergeant with the Carolina Rifles of the 17th Regiment, S. C. V.³³¹ He participated in reunions with his fellow soldiers throughout his life, and collected donations for the reunion in Charleston in 1899.³³² In October 1919, his Confederate pension application was approved.³³³

After the deaths of his parents, he and his family lived in the Tirzah section, near York, South Carolina, on a farm of seventy acres. 334 Like others in his family, he and Sallie raised livestock for meat, milk, and butter. They also grew wheat, corn, oats, and a small amount of cotton 335

Perry also worked in politics, as did his brother, Henderson. In October 1868 they represented their local Democratic clubs and invited the community around Buffalo and neighboring towns to hear speakers at their meetings. Although the Ku Klux Klan was rampant in York County at this time, Perry and Henderson managed to avoid that trouble. Henderson's name appears only once in West's book on the Klan in York County, as a representative from the Buffalo club during the early days of Klan campaigning. 337

Perry got into a spot of trouble when he and others apparently intervened in a street fight. Mr. J. B. Johnson attempted "to cowhide" the Rev. E. G. Price, a Methodist minister, for slandering Johnson's sister.³³⁸ The town fined Perry five dollars for his part in the disturbance.³³⁹

As a well-known member of the community, the local papers often mentioned Perry. In 1892, at a meeting on "the question of Prohibition," Perry attended as one of the representatives from Rock Hill and his brother, Henderson Martin, attended from Blacksburg. Herry served as a juror on several occasions, also. In 1879, the newspaper noted it when he bought land to move to Ebenezer from Tirzah. A few years later "fearful storms" damaged his property. And again, as a "champion snake killer", after he killed twenty-seven snakes under a pile of hay.

Apart from his community activities and farm work, Perry and Sallie actively served their church. The Methodist Circuit Conference, 20 February 1886, recognized Perry's work with Sunday Schools. The membership roll of Adnah Methodist Church for 1896 listed Perry and S. J. Martin along with their daughter, Lula Moore. Perry and Sallie kept a room in their home for circuit riders and visiting ministers. The *History of Adnah United Methodist Church* featured a photo of the Perry Martin family. 348

His brother, Henderson, described Perry as a "jolly fellow" after a two week visit to his home in Ebenezer. ³⁴⁹ In 1905, his cow gave Perry a serious injury when it threw him against a tree and dislocated his shoulder. ³⁵⁰ That same year he and Sally celebrated their Golden Wedding Anniversary, on 6 December. ³⁵¹

Perry's wife, Sarah Jane "Sallie" Beattie, born 1830, died 16 April 1915. 352

24. Minnie⁴ Martin (Perry³, Thomas², Thomas¹) was born about 29 August 1870 in York County, South Carolina.³⁶¹ She married John S. Sadler on 21 February 1894 at her father's home in Ebenezer township.³⁶² Her husband preceded her in death, 5 September 1941 at their home in Tirzah.³⁶³ Minnie died 21 February 1951, also at home in Tirzah.³⁶⁴

Minnie's date of birth is probably correct, although there are discrepancies in the records. The informant gave her age as seven in 1880.³⁶⁵ In 1870, she was not enumerated when the census taker visited on the 24th of June, so she was likely born after that, in August, as recorded on her death certificate.³⁶⁶

John and Minnie Sadler worked as farmers,³⁶⁷ and John Sadler was described as "prominent" in their obituaries.³⁶⁸ John was a landlord and owned real estate for investment.³⁶⁹ When members organized a new Presbyterian church at Tirzah, they elected John as a deacon.³⁷⁰ On the political side, the town elected him Manager of Elections for Tirzah in 1918.³⁷¹ He was also well-known as a fisherman and the newspaper quoted his advice against eating carp.³⁷²

Minnie, a homemaker, "spent her entire life" in Tirzah. ³⁷³ She and her family witnessed the devastation caused by the Great Flood of 1916. ³⁷⁴ She was forty-five with children still at home when her community became isolated from the world. ³⁷⁵ Communications and travel in and out of York County stopped when the Catawba River flooded, broke dams, destroyed railroad bridges, roads, and downed telegraph wires. ³⁷⁶ Thousands in several states lost their homes. ³⁷⁷

She and her family also witnessed both World Wars. Her sons, Roy and John, registered for the WWI draft in 1917.³⁷⁸ Her son, Ben, served during World War II and was stationed in the Panama Canal Zone.³⁷⁹

During Minnie's life, her family participated in the shift away from farm life as more people went to work in factories, particularly the textile mills around York County. 380 Two of her

sons worked in the Bleachery in the 1940s.³⁸¹ Her son, Robert Perry Sadler, retired from The Rock Hill Printing and Finishing Company, now part of history itself.³⁸²

The Sadler family enjoyed making music. Minnie played the organ at her seventy-sixth birthday party, and her nephew Perry played while the family sang songs after her birthday dinner. Six of her seven children attended the party, as well as grandchildren and nieces and nephews. Representations of the seven children attended the party, as well as grandchildren and nieces and nephews.

The children of Minnie Martin and John Sadler were:

APPENDIX A

The Martin Family Burial Ground Also Called Little Bethel Methodist Cemetery

In 1980, members of the Piedmont Historical Society transcribed the inscriptions of gravestones in the Martin Family Burial Ground. This derivative record is the best source available for burial records for some children of Thomas Martin Jr., as explained below.

The transcribers described the burial ground as being "off State Road 11-65, near the SC-NC state line." Many of the individuals listed are connected to Thomas Martin Jr. (1778-1855). The individuals and cemetery described do not appear in the cemetery survey created by the WPA in 1937. The individuals are connected to Thomas Martin Jr. (1778-1855).

Information for The Wrong Cemetery

In the *Find A Grave* memorial for Thomas Martin, (1778-1855),⁴¹¹ the entry is incorrectly associated with a cemetery labeled "Martin Cemetery" with GPS coordinates that identify a location near Web Blanton Court in Cherokee County, South Carolina.⁴¹² A small halfacre parcel near this location holds a Martin grave yard, handed down through the family of Revolutionary War patriot, Martin Martin, as follows:

- Ernest Gerald Martin owned the parcel and the deed referenced an earlier deed of "Misnair and Drusilla Martin" from O. Martin. 413
- "Misnair" and Drusilla were sisters. 414
- Drusilla was a daughter of Robert Martin. 415
- Robert Martin was a son of Martin Martin. 416

The author visited the cemetery nearest the GPS coordinates (35.1264000, -81.7908020) and photographed gravestones there on 26 May 2019. None of the inscribed names appear on the 1980 survey by the Piedmont Historical Society. The names are connected to the records for relatives of patriot Martin Martin: R. W. Martin (Robert Martin), 417 O. Martin (deed: O. Martin), 418 Othello Martin (O. Martin).

Directions to the Correct Cemetery – Little Bethel Methodist Cemetery

In the text description of a Thomas Martin memorial, 420 driving directions to a different location reference a cemetery on private property in Cleveland County, North Carolina, on the state line near Blacksburg, Cherokee County, South Carolina. The author followed the directions given, but no cemetery was visible from the road. The author sent a written query for permission to visit the cemetery with no reply, to date. In a telephone conversation with the photo contributor, he referred to the text description as being the correct location. 422

The Cleveland County GIS map shows the cemetery on a property that is consistent with the text description. In this record, the cemetery is called Little Bethel Methodist cemetery.⁴²³



The parcel containing the Martin Burial Ground is connected to a Cleveland County, North Carolina, deed in book 1157:2187. That deed describes the land as part of a larger parcel described in book 1109:1404, which is a Deed of Distribution from the estate of Sudie Foster Putnam. People mentioned in that deed are connected to James Woodrow Martin, a great grandson of Bird Martin who bought land from Thomas Martin's estate. From his obituary, James Woodrow Martin also lived on Holly Ridge Rd. in Blacksburg, S. C.

Better proof could be made with a study of the chain of deeds from Thomas Martin's land. At his death his land was divided into five lots, four to sell and one for the widow. Those and the later deeds will probably be in four counties: York and Cherokee in South Carolina and Lincoln and Cleveland in North Carolina.

APPENDIX B

Clues to Finding the Birth Family of Elizabeth Martin

The maiden name of Elizabeth Martin, Thomas Martin Jr.'s second wife, has not been proven. She has been attributed with various surnames in descendant family trees. The solution needs to be developed and proven in a separate research project and case study. This appendix might serve as a starting point for future research by the author, or another researcher.

Two surnames appear frequently in family trees on Ancestry and FamilySearch, with one easily disproved and the other not supported with sufficient evidence. Naming patterns may be relevant to the problem and should be considered in future research.

- 1. Many researchers say Elizabeth was the daughter of Gabriel and Priscilla Jones Washburn, but Gabriel's 1826 will and a court case don't support that theory. 430
 - a. Only Thomas Martin's four children by Rhoda were involved in the will and court depositions as heirs of Gabriel. 431
 - b. Gabriel referred to his daughter Elizabeth as Elizabeth Morris in 1822/1823 when Thomas Martin and second wife Elizabeth already had several children together after Rhoda's death. 432
 - Elizabeth Washburn Morris died in Georgia before 1850.⁴³³ Elizabeth Martin lived until about 1868 in York County, South Carolina.⁴³⁴
 - d. It is possible she was a Washburn, but not Gabriel Washburn's daughter.
- 2. Some give her surname as Morris. 435
 - a. This theory is possibly based on Nancy Morris being in Thomas Martin's household on the 1850 census when Elizabeth was 63 and Nancy was 83. 436

- b. Just before November 1848, the poor records of Cleveland County showed expenses for Nancy and Haton Morris, and the wardens of the poor paid for Haton's burial expenses. The wardens reimbursed John McSwain. 437
- c. It is possible Nancy was a sister or other relative and/or the Martin family were housing her as a charitable act. More evidence is needed to determine the relationship.

Applying Traditional Naming Patterns (English) to Thomas Martin's Family

The chart below shows how Thomas Martin's family fits an English traditional naming pattern. 438 Considering the following:

- Family tradition that Thomas fathered twenty children, and two did not survive to adulthood. 439
- Rhoda's children fit the naming pattern well.
- It was common practice to name the first daughter of a second marriage after the first wife. Elizabeth's first daughter was Rhoda.
- Paternal uncles: William, John, Valentine, Josiah, Absalom, Joab, Josiah⁴⁴⁰

Scenario 1 – Morris

• The first daughter born after Rhoda was Nancy. She could have been named after Nancy Morris, who was in the household in 1850. 441

Scenario 1- Bird/Byrd

- Elizabeth may have used her birth surname for her first son's name.
- Marcus and Washington Bird lived near the Martin family in York County.⁴⁴²
- Bird Martin named one of his sons Washington.⁴⁴³
- Marcus Bird of Rutherford County had connections to Grover, North Carolina, and York County, South Carolina. He worked in the Iron industry.
- Absalom Martin may have worked as a puddler (metal/iron worker) during the Civil War. 445
